#### CONTINUING BUSINESS:

Ricky Cramer Ballfield – Supervisor Finch and Councilman Vosburgh met with all parties involved in use of the field discussing field time. It was a good agreement. The wildcard is if a Jr. Sr. league forms. Questions the board will need to decide at budget time will be a maintenance of field, user fee.

Councilman McCulloch asked about the bleacher repair. Supervisor Finch stated that was put off for now and will look into seeing if the Cemetery can take care of. Discussion will also ensue around fencing and Councilman Giordiano would like to discuss removal of trees as a safety issue.

Casings – the Town received a complaint from an individual about Casings not accepting tires from a resident. The original agreement was made in 1995 and amended in 2007 for businesses only; not for individuals.

#### NEW BUSINESS:

Vedder MHP – Supervisor Finch stated Mr. Whitbeck was supposed to attend on behalf of his clients who are the new owners of the mobile home park. Supervisor Finch stated the application and resumes given to the board are good. He is happy with their qualifications and the license can proceed.

Code Fee – Supervisor Finch mentioned the renewal building permit fee structure change to add an incentive for people to finish their projects. Councilman Vosburgh was against this at this time as was Councilmen McCulloch and Giordiano due to COVID and lack of building supply materials. Supervisor Finch stated in theory if someone is close to finishing, it is easier to get a CO with a timelier closeout than if it remains open for years on end.

Councilman Giordiano mentioned the need for updated software to easily track open permits. Supervisor Finch will meet with Mr. Fishman and get a price for the BAS program. He stated the review for the roofing changes will be discussed at a later date.

Halloween Curfew – Supervisor Finch would like all to remember there is a curfew in the Town of Catskill.

Supervisor Finch stated the board will meet tomorrow for the first budget workshop. Councilman McCulloch mentioned the County may be cancelling the Veterans event. Liz will look into.

With no further business a motion to end the meeting was made by Councilman Vosburgh second by Councilman Giordiano. Meeting ended 7:13 pm.
